# Responsibilities:

## Management

All TS Constructions Managers and Supervisors/Team Leaders are accountable and responsible for the safety of workplace participants, contractors and company property under their control so far as reasonably practicable. Integrate quality responsibility into our work practices and work to achieve the quality and environmental expectations of our employees, customers and local community.

### **Employees**

All TS Constructions employees must comply with health and safety legislation, and company policies and procedures by taking reasonable care that their actions do not adversely affect their health and safety for both themselves and other persons. Employees must report all hazards and incidents to their supervisors as soon as possible to ensure health and safety to everyone in our workplace. #### **Contractors**

All contractors engaged to perform work for TS Constructions are required to comply with health and safety legislation, company health and safety policies and procedures and any directions given by management. Work to achieve the quality and environmental expectations of our employees, customers and local community. Failure to comply or observe a direction by the company will be considered a breach of the contract and sufficient grounds for termination of the contract.
